With support from our community, EHT was able to file and emerge victorious in an historic federal lawsuit against the Federal Communications Commission (FCC)! The U.S. Court of Appeals for the D.C. Circuit ruled on Friday that the FCC's decision to not revise its antiquated 1996

wireless safety guidelines was "arbitrary and capricious." The FCC must now explain how it decided that 25-year-old safety standards are relevant to technologies that did not exist 25 years ago.

"It would not surprise me if the FCC reopens the record in order to give the public the chance to comment," said EHT attorney Edward B. Myers. However it decides to proceed, "the FCC will have to provide a reasonable explanation for whatever decision it makes."
