



EHT's Year-End Giving Challenge

Dear Devra,

As we head into the new year, we cannot thank you enough for your support of EHT this year. Because of you, **we transformed the issue on which we have worked for more than a decade.**

With your tremendous support, we won our **landmark case** against the FCC. In August, the U.S. Circuit Court of Appeals for the District of Columbia ordered the FCC to explain why it rejected thousands of pages of science and decided to keep 25-year-old standards for phones and other wireless devices.

The court's order was a stunning rebuke that reverberated around the world and a gratifying moment for all of us who demand that government agencies protect humans and the environment.

Now we have filed **new legal action** to ensure the FCC considers recent science in its response to the court mandate.

This year, **EHT also made great strides through our testimony and briefings to medical doctors, governments, and senior officials from Brazil, Bermuda, the Virgin Islands, and cities in Europe and South America.** We testified to the U.S. EPA and the U.S. FDA. **We also submitted letters to U.S. President Biden and the U.S. Congress** on the need for a national strategy to reduce wireless exposures, develop protective wireless safety limits, address occupational exposures, and minimize the health effects of wireless technology on children.

We launched EHT's letter-writing campaign for the public to call on our elected leaders to support the scientists and to take actions in light of the landmark court win. We hope that you will take a few minutes of your time **to appeal to your representatives** to demand an environmental impact review for 5G and 4G deployment;

to halt 5G and wireless densification until U.S. health and environmental agencies develop science-based wireless radiation safety limits for human, wildlife, and environmental exposures; and to hold congressional hearings to investigate how this issue has been mishandled by federal agencies for the last two decades.

We continued our informational campaign to PTAs and state officials across the country to inform them of the impacts on children from wireless radiation and efforts they can take to ensure children are protected in schools.

In the U.S., officials, policymakers, and concerned citizens in New Hampshire, Washington DC, Washington state, California, and Oregon have sought and used our advice.

We have a ways to go still. With your help, we will get there.

During this uncertain time, the strains on households may leave you with limited funds and many causes that ring true to your heart. We hope that you will see the impacts that EHT is making and support us with a year-end donation that will be used to make important strides toward ensuring that we can reduce the environmental hazards associated with the rise of wireless technology.

Thank you for your support and may you have a successful and healthy 2022.
