

HB 310 will remove local authority for placement of wireless facilities that will expose people in homes and children in schools to a range of wireless frequencies.



Antennas will be placed in front of bedroom windows.





Nationwide Action: Wireless Infrastructure Bills

From coast to coast communities are opposed to streamlining bills. For example:

Ohio Bill SB 331 80 municipalities sued after Bill passed that would limit cities ability to regulate wireless. The Bill was overturned as "unconstitutional."

New York Senate Bill S6687: Directs the public service commission to prohibit the attachment of wireless equipment to existing utility poles in certain circumstances.

Nebraska: Conservative Legislature voted NO

Connecticut: Bill passed to require the participation and input of the local municipality and counter preemption efforts by industry.

California: Heavy opposition now underway with hundreds of cities in opposition.






Radiation Electromagnetic Spectrum

Small Cells and DAS antennas emit a range of microwave frequencies for 2G, 3G and 4G applications.







Limits Set in 1996

- 20 years outdated limit based on 30 year old science
- Accounts only for heating effects.
- Inadequate for children and pregnant women.

Nonionizing Electromagnetic Fields

Myth: No effects At *low* non thermal levels

Fact: Research has found biological effects at low non-thermal levels in thousands of studies.

Since the IARC classification, the evidence *has increased* which finds radiofrequency exposure associated with increased brain cancer risk.




Cancers in NTP Rats Parallel Findings from Human Epidemiological Studies

Increased Gliomas in Brain



Increased incidence of brain gliomas reached statistical significance in males with CDMA modulation.

Increased Schwannomas





GSM or CDMA modulations of RFR in male rats resulted in a statistically significant, positive trend in the incidence of schwannomas in heart.

Multiple research studies and reviews find significant effects.




Testis slides show significantly increased i-NOS immunostaining in the spermatogonial cells


Mice exposed to nonthermal Wi-Fi 2.45-GHz 2h/d x 30 d

Neurological Development Damaged by Radiofrequency Radiation: Multiple Published Studies










Wireless radiation penetrates into children's brains and bodies more deeply than into adults- Up to two times in their brain and ten times into the bone marrow of their skull. Their brain and immune system is still developing.

Sweat glands act as helical antennas when exposed.





10 WAYS TO HELP REDUCE YOUR EXPOSURE.

#Know Your Exposure

- Avoid carrying your cell phone on your body (e.g. in a pocket or bra).
- Avoid holding any wireless device against your body when in use.
- Use your cell phone on speaker setting or with an "air tube" headset.
- Avoid using your wireless device in cars, trains or elevators.
- Avoid cordless phones, especially where you sleep.
- •Whenever possible, connect to the internet with wired cables.
- When using Wi-Fi, connect only to download, then disconnect.
- Avoid prolonged or direct exposure to Wi-Fi routers.
- *Unplug your home Wi-Fi router when not in use (e.g. at bedtime).
- Sleep as far away from wireless utility meters (i.e. "smart" meters) as possible.

Biological effects reported after exposure in populations living near base stations from exposures at levels far below current exposure guidelines.

"Biological effects from exposure to electromagnetic radiation emitted by cell tower base stations and other antenna arrays" *Environmental Reviews*, Levitt and Lai 2010

 Research has found headaches, skin rashes, sleep disturbances, depression, decreased libido, increased rates of suicide, concentration problems, dizziness, memory changes, increased risk of cancer, tremors and other neurophysiological effects in populations near base

10 year Brazilian: A clearly elevated relative risk of cancer mortality at residential distances of 500 meters or less from cell phone transmission towers.

RF Effects Sleep



Dose-response relationship between EMF field intensity and its effects on brain physiology as demonstrated by changes in the sleep EEG and in cognitive performance. - Regel et al (2007)

"Consistent with previous findings, our results provide further evidence that pulse-modulated RF EMF alter brain physiology." - Schmid et al (2012)


Exposure was associated with a prolonged latency to reach the first cycle of deep sleep (stage 3). The amount of stage 4 sleep was also decreased in exposed subjects. Subjects reported more headaches during exposures vs. sham exposure. - Bengt et al (2007)

Tablet at 150 mm (5.9 inches) from eye lens





Eye Blink Protects Eye From Damage?

US Government assurance of "low risk" is based on the premise that eyes will close in millimeter wave beam.

"AFRL researchers concluded and the HEAP panel concurred that the probability of eye damage caused by ADS exposure is very low. The innate blink reflex causes the eyelid to close upon sensing of the millimeter wave energy, protecting the eye from damage."





Cell Phones are not radiation tested in body contact positions.



Why So Many Inconsistent Results?



Huss 2007: Systematic review- industry funded studies 90% less likely to report effect.

Valentini et al. 2011: "the existence of sponsorship and publication biases should encourage WHO intervention to develop official research standards and guidelines."

Cell Phone Calls and ADHD Potentiation of Lead Toxicity in Korean Children



"combined or cooperative toxic action of RF and lead on the developing brain."

Byun et al. 2013 PLoS

2,422 children - 27 schools - 10 Korean cities - 2 y follow up ADHD symptoms associated with voice calls, *only among children with higher blood lead values (>2.35µg/dL; comparable to U.S. BLLs)*Byun et al. 201


American Academy Of Pediatrics (AAP) Recommendations

- 2012: Urged support of Federal Legislation HR 6358 to develop safety standards and inform the public.
- 2013: Urged FCC to reevaluate RF guidelines to ensure they protect children and pregnant women and reflect current use patterns in testing and regulatory limits.
- 2016: Reduce radiofrequency radiation: After NTP study results released AAP issued "Ten Tips" to reduce children's radiofrequency radiation.

Solutions

Premarket safety testing before infrastructure development, postmarket surveillance, fiberoptoics and wired technology, R and D, proper safety standards to be set.

Manufacturers' Fine Print Safety Advice On All Cell Phones and Wi-Fi Devices about Tested Distances



"To maintain compliance with FCC's exposure guideline, place the child unit at least 20 cm (8 inches) from nearby person's"- First Years Baby Monitor Manual

Body- worn SAR testing has been carried out at a separation distance of 1.0 cm. To meet RF exposure guidelines during body worn operation, the device should be positioned at least this distance away from the body.



"Risk from dangers linked to EMF can be classified as an emergent risk"— the same category once occupied by asbestos


General Insurance Exclusions: Electromagnetic fields directly or indirectly arising out of, resulting from or contributed to by electromagnetic fields, electromagnetic radiation, electromagnetism, radio waves or noise.

RF EMF Legal Exposure Limits and Nonbinding Recommendations in Different Countries





In lifetime cancer study EMF creates synergistic effects with ionizing radiation



Age at Detection in Female Rats

650 Exposed /1,001 controls

- Lifespan exposure from in Utero
- 50 Hz EMF (200 mG or 10 G)
- One time dose 0.1Gy at 6 wk

Results = Increased

- mammary adenocarcinomas (both sexes)
- incidence of heart malignant schwannomas (males)
- hematopoietic neoplasias [leukemia and lymphoma] in males treated at 1,000μT plus 0.1 Gy.

(Soffritti et al., 2016)

"These results call for a reevaluation of the safety of non-ionizing radiation."



World Wide Precautionary Action



France: Phones sold with headsets. Wi-Fi Banned for Kindergarten/Wi-Fi off when not in use. New national law



Belgium: Banned cell phones for children.



Israel: Wi-Fi to be removed from all Haifa schools as of April 2016, Health Ministry recommends lowering exposure at home and school.



Italy and Spain: Several local governments voted to declare precautionary principle: protect children and use wires.



UK, Switzerland, Australia, Germany, Canada: Health agencies recommend reduced cell phone exposures.



India: Exposure limits lowered to 1/10 of the ICNIRP level, recommendations to reduce cell phone exposure, SAR labeling on phones, some govs ban towers near schools.



Maryland State Children's Environmental Health and Protection Advisory Council, 19 Members (pediatricians & public health)

Purpose: To identify environmental hazards that may affect children's health and recommend solutions/guidelines to reduce and eliminate hazards.

Council is considering the safety risks of cell towers now.

"The Council recommends limiting exposures as much as feasibly practical."

"The Maryland Department of Health and Mental Hygiene should provide suggestions to the public on ways to reduce exposure.

The United States Department of Health and Human Services to formally petition the FCC to ensure the FCC exposure limit is protective of children's health and that it relies on current science".

- Headaches
- Memory problems
- Dizziness
- Depression
- Sleep problems




The AAP lists 10 ways to reduce exposure to children and has urged US government for review of RF.
